## INTERNATIONAL VISITING STUDENTS POLICY & PROCEDURE - TCS-201

### I. INTERNATIONAL VISITING STUDENT DEFINITION:

An international visiting student is defined as a student who is not a Canadian citizen or permanent resident of Canada currently studying at Trinity Christian School for a short term visit of 2-5 months.

### II. APPLICATION PROCESS:

**STEP 1:** All International Visiting Students must provide the school with the following documents:

(Photocopies are acceptable.)

- ⤴ Policy Form (TCS-201)
- ⤴ Application Form (TCS-202)
- ⤴ Fee Form (TCS-203)
- ⤴ Statement of Christian Nurture (TCS-105) – Home stay only
- ⤴ Passport
- ⤴ Notarized Guardianship document. – Home stay only
- ⤴ Registration Fee CD\$1000 (non-refundable)

**STEP 2 :** Letter of Acceptance will be issued, upon receipt of all fees and documents confirmed by Boards.

**STEP 3 :** Submit following documents before the first day of school :

- ⤴ Medical Insurance
- ⤴ Immunization Record in English

### III. POLICIES:

- ⤴ Trinity Christian School's **Student Admission Policy & Procedure** governs all enrolments, including International Students.
- ⤴ Students admitted will be subject to the school's **Discipline Policy** and must comply with the school's **Student Code of Conduct**.
- ⤴ Following the guidelines of the existing **Student Admission Policy & Procedure**, only international students from Christian families will be admitted.
- ⤴ It is the responsibility of the international student's family to obtain a passport, student visa and medical insurance prior to commencing studies at Trinity Christian School.
- ⤴ The maximum number of International Students not to exceed **three** who require ESL and **five in total** in any given classroom.
- ⤴ Unless the valid and true documents in Step 1 are submitted, students will not be permitted to attend school until valid document(s) are received by the school office.
- ⤴ Each year, by June, The Board of Directors will determine the tuition cost of International Students.
- ⤴ **ESL:** ESL instruction will be provided for visiting international students.
- ⤴ **Accommodations:**  
Students living apart from parents must reside with either a blood relative or with an unrelated but supportive family unit either of which must provide, safe and Christian nurture.
- ⤴ **School Bus:**  
International students must reside within Trinity's transportation boundaries, if they want to use school bus service. Additional costs may apply if the student resides outside of Trinity's transportation boundaries and bussing is deemed possible.
- ⤴ **Age/Grade Placement:**
  - International students who are living with a host family apart from parents will only be considered for placement in Grade 3-8.

- International Students are placed in age-appropriate grade levels so as to provide the students interactions with same age peers at similar social/emotional development. However, there may be exceptions made due to class sizes and student ability.

**AGREEMENTS**

\_\_\_\_\_ I understand that my child is subject to the authority invested by the board, principal, vice-principal, and classroom teachers in harmony with the bylaws of the Burlington Parental Christian School Society. I understand that my child will be subject to all the school's rules and guidelines while enrolled as a student at Trinity Christian School. I understand that my child must abide by all the laws of Canada. I understand that the unlawful use of drugs will not be tolerated and that alcohol use is also forbidden in all circumstances. I understand that the violation of the above will result in my child's dismissal from the school. I understand that in the case of dismissal, my child will be sent home at the expense of the parents.

**Refund policy**

- ⤴ Registration Fee (\$1,000) is not refundable.
- ⤴ All fees and tuition except Registration fee (\$1000) will be refunded, if Canadian Embassy does not approve Student Visa. The original reject document must be submitted to the school office.
- ⤴ If registration is cancelled before the start of school, all fees will be refunded, except 50% of tuition and registration fee.
- ⤴ If registration is cancelled on or after the first day of school, there is no refund.
- ⤴ Fees may not be transferred to the next term or school year once paid for the current term or year.
- ⤴ There are no refunds for days in which the International Visiting Student did not attend school.
